NEW MEMBERSHIP SPECIAL: *Sign up today for bonus months of membership for the price of 12 months dues for any category. That is a substantial savings on any membership. There's no initiation fee and your annual dues are good until May 31, 2009! Minimum is waived until June 1, 2008.*

Dues may be paid in quarterly installments with an administrative fee of \$25.00 per quarter. If quarterly payments are elected, dues payments are due by June 1st, September 1st, December 1st, and March 1st.

Minimum: In addition to dues, a minimum for CHARGED food and NON-alcoholic drinks (not including tax & tip) is set at \$105.00 per quarter for every membership category. If you exceed \$350.00 for any quarter in CHARGED food and alcohol purchases the minimum is satisfied. Junior golf is exempt.
